Impartiality Policy of ICAS

- 1. Shanghai Ingeer Certification Assessment Co., Ltd (ICAS) is a third-party certification body with independent legal status. We fully understand that impartiality plays an important role in the validation/verification activities. ICAS would always stick to the principle of impartiality and non-discrimination in the validation/verification activities; and treat all of our validation/verification clients equally. ICAS would not allow commercial, financial or other pressures to compromise impartiality.
- 2. ICAS would comply with the relevant national statutory and regulatory requirements of certification and accreditation, relevant requirements by CNCA, UKAS accreditation standard, ANAB accreditation standard and other statutory and regulatory requirements of validation/verification and accreditation as well as regulatory requirements in order to ensure the work is carried out in an independent, impartial, transparent and efficient way.
- 3. ICAS is a service entity which offers single validation/verification activities, its service scope is limited to validation/verification activities for the client and related validation/verification activities. ICAS promised that it would not outsource validation/verification to management system consultancy organization. The marketing and quote of ICAS validation/verification activities have no relations with relevant consultancy bodies. - 5. ICAS would maintain impartiality and independence on the three levels of strategy; and policy making; and validation/verification execution, decision and issuance.
- 6. ICAS and its engagement of validation/verification, acceptance, planning, validation/verification execution, review, decision maker and issuing officer and all personnel who participate in the validation/verification process have no opportunity to affect the validation/verification process. ICAS would neither participate in any kinds of activities which may compromise the impartiality, science and objectivity, nor provide any services which may compromise

ICAS accepts and copes with management surveillance from all interested party in the society.
